MAIL YOUR ENTRY

After receiving e-mail confirmation of your registration, please send softcopy of your sustainability report to be assessed and company logo.

REGISTRATION REQUIREMENTS

 - Period 1: IDR20.000.000 or USD1,430 (Register and Pay), Max June 30, 2024
 - Period 2: IDR22.000.000 or USD1,570
