SUSTAINABLE DEVELOPMENT GOALS (SDGs)

The SDGs call for worldwide action among governments, business and civil society to end poverty and create a life of dignity and opportunity for all. We will detail as well the sustainable development goals. Climate change, human rights, poverty – sustainable development addresses all these global issues and more. To contribute to sustainable development, we all have a role to play: from global bodies to local governments and regulators to business. The private sector cannot thrive and grow in a world of poverty and environmental stress and so it has vital interest in ensuring the achievement of the 2030 Agenda for Sustainable Development and its 17 Sustainable Development.



As part of the reporting journey, many organizations experience both internal and external benefits of sustainability reporting. Reporting demonstrates organizational commitment to sustainable development and allows for comparing organizational performance over time. The following benefits have been identified based on research

- Sustainability reporting sets direction by placing the organizational purpose, vision and strategy into the wider context of sustainable development, which helps make abstract issues more tangible and concrete.
- Sustainability reporting requires comprehensive and efficient management systems, which improve the quality of data and contribute to its distribution. Data tracking creates opportunities for improvement, efficiently and cost savings. It also helps set goals, measure performance and manage change.
- Sustainability reporting facilitates risk management. Early identification of emerging issues helps seize opportunities and evaluate potentially

damaging developments before they occur.

- 4. Sustainability reporting engages the workforce in sustainability efforts, increases productivity, attracts new talent, and reduces absenteeism.
- 5. Proactive and transparent communication about sustainability efforts and impacts builds trust and reduces reputation risk while also improving product image and brand name.
- Attract capital: Reducing risk through sustainability management and communication helps signal quality, good management and secure investment, providing potential for new sources of capital and lower costs.
- Engage with stakeholders: Sustainability reporting is a powerful tool to build or restore trust among stakeholders and respond to stakeholder demands for greater transparency.
- 8. Sustainability reporting ensures compliance with evolving regulatory requirements at local and global levels.



## **GRI** ABOUT THE GLOBAL REPORTING INITIATIVE (GRI)

The Global Reporting Initiative (GRI) is an independent, international organization that helps businesses and other organizations take responsibility for their impacts, by providing them with a global common language to communicate those impacts, through the use of the GRI Standards. The GRI secretariat is headquartered in Amsterdam, the Netherlands, with a network of seven regional hubs to support organizations and stakeholders worldwide.

The GRI develops the sustainability reporting standards through a multi-stakeholder process that incorporates the active participation of various stakeholders from areas such as business, non-governmental organizations, research institutions from around the world.

## WHO SHOULD ATTEND THIS TRAINING?

This course is suitable for sustainability practitioners, reporters, C-suite executives, students or others with an interest in the field of sustainability reporting. This training is also suitable for report users such as NGOs, Financial Analysts, Government Officials, and Media.
